Wings of Light, Inc. is a national nonprofit organization dedicated to assisting those touched by aircraft accidents. The most important goal of the organization is to bring people together through the existence of three support networks.

Survivor Support Network

The Wings of Light Survivor Support
Network is a support group for those who
have been involved in and lived through an
aircraft accident. This group helps
individuals understand the feelings and
issues of surviving the accident and coping
with the impact on their lives.

Family and Friends Support Network

The Wings of Light Family and Friends Support Network provides families and individuals with specialized support that addresses the unique issues surrounding aircraft fatalities.

Rescue/Response Personnel Support Network

The Wings of Light Rescue/Response Personnel Support Network brings together individuals involved in the rescue, recovery and investigative efforts. An often overlooked group, individuals in this network are given a forum for peer counseling and voicing concerns.

Other activities include the development of local chapters, the planning of a conference for network members, distribution of related informational materials and resource kit, and referral to qualified counseling professionals.

Handbook Helps Others Understand


Founder of Wings of Light, Andrea Waas, tells the story of the crash in which her father was killed that led to her work in helping others in new book about providing assistance to survivors of mass transportation, military and other disasters. Handbook for Human Services Response: A Practical Approach for Helping People, by Carolyn V. Coarsey, Ph.D., features stories of passenger and family survivors of airline crashes, general aviation crashes, military crashes and other disasters, along with interviews with leaders and helpers who responded. All of the interviews and stories are woven around practical guidelines for helping others that can be practiced by anyone who desires to help others.

Andreas's story...

I guess it was about 7:00 in the evening and I had just sat down to eat dinner the phone rang it was my mother on the other end of the phone and she said "Andrea, your father has been killed in a plane crash."

My response was immediate denial. I said, "No don't tell me this!" At that point we didn't know much about it at all. We just knew that there were three people on the airplane. One person had survived and it was not Dad. There was no confirmation vet on the two individuals who had been killed



I know I didn't sleep at all that night. Since it had not been confirmed as to who had been killed, I kept hoping that the phone would ring and someone would tell me that it wasn't Dad who was on the airplane

I had talked with him two days earlier, it was his birthday He told me that he was going to be taking a flight up to Lincoln, Nebraska with a couple of friends

Immediately following the accident, I wanted to know everything

I called the local newspaper. I didn't tell them who I was, I just said I was interested in any photographs they had of the accident site and they sent me contact sheets. I immediately ordered enlargements from the contact sheets and, being a pilot myself, I contacted the FAA. I knew I could get a written copy of the transcripts of the last transmission and I could also get an audiotape of the last transmission between the aircraft and the tower.

I did all right with the written transcripts, but listening to the audiotape was very, very difficult to do. At one point, the controllers get very upset because they are trying to reach my father and there's no response and their voices begins to shake. To this day, that bothers me—to hear that. Then one of them came on and said we have a report of smoke two miles north of the airport and it gets very quiet

It was very helpful to have the information it was one of the very, very difficult things to go through

It was hard for me to realize that he was really gone. The funeral itself involved a closed casket because of the intense fire. The photographs that I had gotten from the newspaper did show Dad from a distance in the airplane and it was my father's profile. Seeing this helped me a lot in accepting the fact that it was Dad and he is dead and he is gone

I was able to get permission to enter the hangar where they had the wreckage. At that time they had finished with everything they needed from the wreckage. They kept a couple of parts that were still under investigation but for the most part the rest of the plane was there . . . This was very helpful

When I went to Kansas City to be with my mother, I stayed there for about a week with her. During that time, I was the one who would answer the telephone and to my shock, a lot of the phone calls were for Dad The typical conversation was always my answering the phone them asking for Al I'd say who's calling please? They'd tell me who was calling and I'd say I'm sorry but my father was killed in a plane crash. And their response was, "oh I was afraid that was him, I was hoping it wasn't." It was very, very difficult for what I was going through at the time to continuously answer the phone and have them know Dad had been killed-and still they called to ask for him

It took a couple of years for the accident report to come out. About the time that the NTSB released the final report I was going

through graduate school and I was getting my Masters in Business and one of the requirements was doing a business plan and I chose to do the business plan on starting a new national non-profit organization to assist survivors of aircraft accidents, as well as family members of individuals who are killed in aircraft accidents. At the time I felt that there was probably not a need for such an organization. I thought I was alone in my feelings of wanting to talk to other people who had been through the same thing. And much to my surprise, after the research I did, there was a tremendous need for an organization like this. There are no other organizations out there that do this type of thing.

It was after I got the research back in my master's project that I decided to start the organization
